



Springville Chamber of Commerce **Fall 2018 Photo Contest Rules**

Who can enter: anyone except board members of the Springville Chamber of Commerce is eligible to enter. Entries deadline is December 1, 2018.

Photographs should have been taken no earlier than January 2016.

Category #1: *Best photograph of one of the following Chamber Member businesses. Success Lake Marina, Fair Finds, or Family Healthcare Network.*

Category #2: Photographs depicting local recreation, tourist activity or local scenery.

Guidelines For Both Categories:

Photographs will be judged on creativity, quality, originality, responsiveness to the prompt and overall impact.

Photographs should be taken in high enough resolution to be displayed on the chamber's website, but no more than 10mb in size. Entries w/out sufficient resolution to be displayed on the website will be disqualified. Entries should be in jpg or gif format. No print photographs will be accepted.

Winners will be announced at the January 12, 2019 Chamber of Commerce/Lions 'Casino Night' event.

All entries must be original work and not previously published. Multiple entries are allowed.

Altering photographs is accepted; however it may be deemed by the judges that extensive altering reduces its responsiveness to the prompt, and thus will reduce its chances of winning.

Entries will be judged by the board of directors of the Springville Chamber of Commerce. The past president, as the administrator of the contest, will not judge. The judges may choose no winner for a particular category if they find no photo that, in their estimation, merits award. Judges decision will be final.

Photographers retain the rights to their entries, but by entering the contest, entrants grant The Springville Chamber of Commerce royalty-free, world-wide, perpetual, non-exclusive license to publicly display, distribute, reproduce and create derivative works of the entries, in whole or in part, in any media now existing or later developed, for any Springville Chamber of Commerce purpose, including, but not limited to, advertising and promotion of its website and commercial products. The Springville Chamber of Commerce will credit the photographer if feasible.

Entries may be submitted via email or facebook. An official entry form and any necessary model releases should be emailed to chamber@springville.ca.us before December 1, 2018. Multiple entries may be made with one entry form, but the entry form must list all of the photographs entered.

Winning entries will be promoted on the Chamber website, through facebook and in a press release to local newspapers.

*****1 First Place winning Entry will receive \$100.00 cash, a gift certificate from a chamber-member business, and a winner's certificate.**

*****1 Second-Place winning entry will receive \$50.00 cash and a winner's certificate.**

*****1 Third-Place winning entry will receive \$25.00 cash and a winner's certificate.**
